ORDER

WHEREAS, the recognition was granted to the institution namely **Gokak Education Society's College of Education, Falls Road, Gokak, Belgaum District-591307, Karnataka** run by **Gokak Education Society, Gokak, Belgaum Dt. Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2005-2006/4822 dt. 21.12.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 30.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, a letter was sent to the institution regarding V.T Inspection on 22.06.2016. As per the decision of SRC the inspection was conducted on 22.10.2016 and the V.T report received in this office on 24.10.2016.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a First show cause notice was issued to the institution on 06.11.2019. The institution vide letter dated 19.11.2019 submitted its reply to the First show cause notice.

5. **AND WHEREAS**, the SRC in its 383rd meeting held on 07th – 9th January 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued on 16.01.2020. The institutions vide letter dated 08.02.2020 submitted reply to the Final Show Cause Notice. The SRC in its 385th meeting held on 03rd March, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

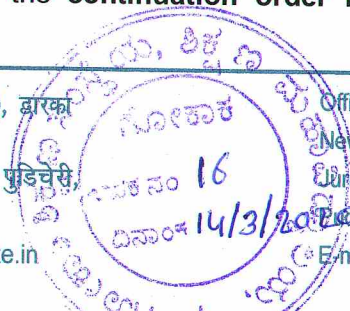

6. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Gokak Education Society's College of Education Sy. No. 215/2, 221/1A/1/2, Near Basaveshwar Circle, Fals Road, Gokak, Belgaum District-591307, Karnataka** run by **Gokak Education Society, Gokak, Belgaum Dt. Karnataka** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (**2 basic units**) of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;

- f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution **Gokak Education Society's College of Education, Falls Road, Gokak, Belgaum District – 591307, Karnataka** has by affidavit consented to come under New Regulations and sought for two basic units in **B.Ed** which require additional facilities.

3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
- II. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- III. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Gokak Education Society's College of Education, Falls Road, Gokak, Belgaum District – 591307, Karnataka** for conducting **B.Ed** programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session **2015-16** subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.



ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Gokak Education Society, Gokak, Belguam Dt., Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Gokak Education Society's College of Education, Falls Road, Gokak, Belguam Dt. -591307. Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.
 - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3.2 lakhs.
 - d. The institution has selected the Principal and Seven lecturers for the said course and the list of faculty members has been approved by the affiliating University.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Gokak Education Society's College of Education, Falls Road, Gokak, Belguam Dt. -591307. Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
 - a. The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - c. The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
